PROGRESS SO FAR

- Over 100 vulnerable children and young people's files will be read by the inspectors. Your service will already have been contacted.
- Inspectors have conducted an on-line staff survey across the Partnership, with Named Persons and Lead Professionals. The results of this survey will inform the scoping exercise.
- A self-evaluation document has been submitted by the Partnership to the Care Inspectorate. This is a joint piece of
 work by the Partnership, involving contributions and evaluations from all services. Position Statements on the
 implementation of GIRFEC, Corporate Parenting and Child Sexual Exploitation have also been provided. Four examples
 of partnership good practice have also been submitted; Mobile Alcohol Intervention Team (MAIT), Early Years
 Collaborative, Springfield Project and Get On My Level (Teen Pregnancy).

THE SELF-EVALUATION DOCUMENT

In addition to giving some contextual information, the documents include evidence and evaluations on each of the 22 quality indicators used by the Care Inspectorate. Each quality indicator is accompanied by a statement of "key strengths" and "areas for improvement". The evidence forming the basis of the evaluations was gathered from the Children's Partnership in Fife.

The self-evaluation provides strong and comprehensive evidence of the quality of the joint work both at strategic and operational levels between partners. Most importantly of all, it identifies the very good outcomes (quality indicator 1.1) being delivered across the wellbeing indicators for our children and young people. In reaching this evaluation use has been made of trend information, comparisons to national statistics and to similar areas in Scotland.

All quality indicators that are reported on by the Care Inspectorate we have graded as "good" or "very good" in our self-evaluation.

The four areas of good practice, using the Care Inspectorate's criteria of multi-agency working and the measurable difference being made to the lives of children and young people, are:

- The Mobile Alcohol Intervention Team (MAIT)
- Early Years Collaborative
- Springfield Project Therapeutic Service for looked After Children
- Get On My Level Targeted Teenage Pregnancy Interventions

THE NEXT STEPS IN THE PROCESS AND HOW YOU MIGHT BE INVOLVED

- **17 August 2015**: Inspectors read the information provided, and available to them from other sources, to start scoping the inspection.
- **24 28 August 2015**: Senior managers from the Partnership will meet inspectors to continue the scoping exercise. Inspectors will attend a range of strategic meetings.
- 14-18 September 2015: Inspectors, assisted by four staff from Fife, read and review the information contained in the sample of vulnerable children's files with the aim of reaching a view on practice. This stage will result in inspectors confirming arrangements for discussions with the "Team Around the Child" which may involve some of you.
- **5-9 October 2015:** Inspectors meet with "Teams Around the Child", children, young people, parents and carers; hold interviews with key members of staff; conduct single or multi-agency focus groups; visit services and observe groups or key processes.
