### Areas of good practice

- The report highlighted nine areas of good practice.
  Seven of these are from the voluntary sector:
  - Alzheimer Scotland volunteers and community connections for people with dementia and their carers
  - The Ecology Centre the tool shed
  - Fife Employment Access Trust mind your mind
  - Furniture Plus maintenance plus
  - LinkLiving realLiving network
  - Nutshell and OnatFife still points in a turning world
  - Fife Voluntary Action Footcare Fife



## **Areas for improvement**

 The Fife Partnership should ensure its independent, private and voluntary sector partners are enabled to make a positive contribution at all levels to providing positive outcomes for older people.



# Highlights from quality indicator 4 – impact on the community

- Strongly reports on projects included in the Reshaping Care for Older People Community Capacity Building programme.
- Recommendations:
  - Progressing the development of social enterprise
  - Supporting the development of low-level interventions as informed by older people
  - Developing a sustaining network of community supports
  - Increasing the capacity of the third sector interface



#### Role of the third sector

- The third sector makes an important contribution now and will need to play a greater part in future. The report concludes the Fife partnership should ensure it has robust arrangements in place for third sector involvement as part of the integration.
- They found that the Fife partnerships relationship with the third and independent sector had been mixed and could be strengthened.
- It is recommended that the Fife partnership should build on its work with the third sector and private providers and set out its direction within the strategic commissioning plan.
- It is recommended that the Fife partnership build capacity of the third sector interface.



### Opportunities for the third sector

- There was some scope for improvement in relation to involving independent advocacy services. This would ensure that older people's views would be represented.
- The Fife Partnership delivered slightly less respite to older people and their carers than the Scottish average
- The report recognised the important contribution the third sector makes, however they reported limited evidence of current and robust evaluation of all these projects or evidence of long-term plans to support their development.
